

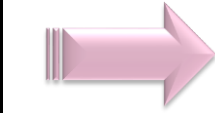

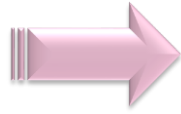
## Schedule 3: Final Planned Unit Development Application Review Schedule\*
