2021 Specific Purpose Tax Information Guide

Laramie County, and the Towns of Albin, Burns, Pine Bluffs and City of Cheyenne

Election Day: November 2, 2021



What is the Sixth Penny Tax?

State law allows counties, in cooperation with cities and towns, to fund specific projects through a voluntary sales tax. Counties, cities, and towns pass resolutions that include proposed projects and amounts needed to complete those projects. Voters are then asked to vote on those projects. If approved by the majority of voters, a "sixth penny" sales tax is added to your purchases. When the specific amount is collected, the tax stops. Laramie County is comprised of: The City of Cheyenne and the towns of Albin, Burns, and Pine Bluffs.

How does the ballot work?

Voters will be presented with similar projects grouped together in four different areas: public safety, roads, infrastructure, and community enhancements.

How can I vote?

You can vote on election day - November 2, 2021 - or you can vote early or by absentee ballot beginning September 17. Early voting is available in the Atrium of the Laramie County Building (309 W. 20th St.) from 8:30 a.m. to 4:30 p.m., Monday through Friday until November 1. An ID will be required to vote. Why do I have to show an I.D. to vote?

Wyoming law now requires you to present an ID before voting in person on Election Day or during early voting. Bring your Wyoming driver's license or Wyoming ID. Other acceptable IDs: military ID, valid U.S. passport, Wyoming student ID, driver's license from another state, Medicare or Medicaid card. Questions? Call our Election office at (307) 633-4242. Will tourists pay this tax?

Yes. Anyone who purchases items in Laramie County (except non-prepared food) will pay this tax.

\$3,000,000 to City of Cheyenne and the interest earned thereon to Match Grant Opportunities Project to provide funding to match grant opportunities benefitting the city of Cheyenne

\$2,250,000 to City of Cheyenne and the interest earned thereon for Cheyenne Regional Airport for a Minimum Revenue Guarantee
