## **AGENDA ITEMS**

12. ORDINANCE – 2<sup>nd</sup> READING – Amending Sections 1.4.3, 2.1.1, 2.1.2, and 4.2.5 of the Unified Development Code of the City of Cheyenne, Wyoming, to define and clarify the purpose of remainder lots. (SPONSOR – MR. CASE)

Mr. Roybal moved to approve on 3<sup>rd</sup> and final reading, seconded by Mr. Cook. Motion carried by unanimous voice vote.

**DISCUSSION:** Charles Bloom, Planning & Development Director, provided a staff report and advised that no additional information has been provided since second reading at the May 26, 2020 meeting of the governing body and staff continues to support approval.

13. ORDINANCE – 2<sup>nd</sup> READING – Amending Section 2.2.6 of the Unified Development Code of the City of Cheyenne, Wyoming, to modify time limits associated with temporary uses. (SPONSOR – MR. CASE)

Mr. Roybal moved to approve on 3<sup>rd</sup> and final reading, seconded by Mr. Cook. Motion carried by unanimous voice vote.

**DISCUSSION:** Charles Bloom, Planning & Development Director, provided a staff report and advised that no additional information has been provided since second reading at the May 26, 2020 meeting of the governing body and staff continues to support approval.

14. ORDINANCE – 2<sup>nd</sup> READING – Amending Sections of Article 2 of the Unified Development Code of the City of Cheyenne, Wyoming, to modify posted notice requirements for site plans and administrative approvals, clarify procedures for

modification of site plans, modify authority to initiate text amendments, and modify criteria for variance approval. (SPONSOR – MR. CASE)

Mr. Cook moved to approve on 3<sup>rd</sup> and final reading, seconded by Mr. Roybal. Motion carried by unanimous voice vote.

**DISCUSSION:** Charles Bloom, Planning & Development Director, provided a staff report and advised a drafting error was located in Section 10 but has been corrected and the final draft of the ordinance will include corrected language.

25. RESOLUTION – Declaring June 2020 as 307 First Month. (SPONSORS – MR. CASE, MR. COOK, MR. LAYBOURN & MR. WHITE)

Mr. Cook moved to adopt, seconded by Mr. Roybal. Motion carried by unanimous voice vote.

**DISCUSSION:** Bryan Cook, Councilman Ward II, advised he was contacted by Chad Craig, 307 First, to bring this ordinance forward to encourage shopping and buying in Wyoming first. Mr. Craig explained the company was first started in 2013 to help Wyoming contractors earn in state preference and voiced the importance to support Wyoming business first by shopping and buying locally.
