## **AGENDA ITEMS**

15. RESOLUTION – In appreciation of the teachers of Laramie County School District Number One and Laramie County Community College for their exceptional efforts during the Covid-19 Pandemic. (SPONSOR – MR. LAYBOURN)

Mr. Roybal moved to adopt, seconded by Mr. Cook. Mr. Shanor moved to amend by substitute, seconded by Mr. Roybal. Motion to amend carried by unanimous voice vote. Main motion, as amended, carried by unanimous voice vote.

**DISCUSSION:** Pete Laybourn, Councilman Ward 1, advised he wanted to submit this resolution to acknowledge appreciation for teachers during the Covid-19 pandemic. Upon inquiry, Mr. Laybourn was supportive of including and clarifying more participants in the resolution such as, leaders, support staff, parents of students, bus drivers, nutrition staff, and councilors. **DISCUSSION:** Seth Lloyd, Planning & Development Department, provided a staff report and advised staff supports approval to divide one large parcel into 16 parcels for single family residential development. Mr. Lloyd reported a revised map was submitted which resolves 8 staff conditions. Upon inquiry, Casey Palma, Steil Surveying advised the business currently located on the east end of the proposed development is aware that all vehicles located on that parcel will need to be removed before construction starts and noted the the start date of construction is uncertain.
