The changes, clarifications, omissions, additions, and/or alterations in, on, and to the bid information and specifications shall apply to the Invitation For Bid submitted for and to the project indicated above. Except as modified by this Addendum Number One, all of the terms and provisions of the Invitation for Bid for the above listed project remain in full force and effect. This Addendum Number One supersedes all previous instructions pertaining to the items listed:

CLARIFICATIONS:

C1: Bid Page 14, Warranties, Power Train Warranty, is updated as follows:

"2. Power train – 5 year/100,000 miles. (May be Standard Warranty or Add-On Extended Warranty). If Add-On Warranty, include this in the overall cost of each unit."

C2: Bid Page 14, Warranties, Destination Sign Warranty, is updated as follows:

"10. Destination Sign – 10 year minimum. If extended or add-on warranty is required to extend standard term to 10 Years, include this in the overall cost of each unit."

C3: Page 18, Anticipated Date of Delivery Agreement, is updated as follows:

Vehicles will be delivered within **the number of days ARO (After Receipt of Order) as stated on the Bid Price Proposal Form** ~~+20 calendar days from the date of the Purchase Order~~. In the event that delivery of vehicles is not made within **the number of days ARO (After Receipt of Order) as stated on the Bid Price Proposal Form** ~~within 120 calendar days from the date of the Purchase Order~~, CITY shall assess liquidated damages.
