

 - Class 5 Two-Axle, Six-Tire, Single-Unit Trucks
 - Class 6 Three-Axle Single Unit Trucks
 - Class 7 Four or More Axle Single Unit Trucks
 - Class 8 Four or Fewer Axle Single Unit Trucks
 - Class 9 Five-Axle Single-Trailer Trucks
 - Class 10 Six or More Axle Single-Trailer Trucks
 - Class 11 Five or Fewer Axle Multi-Trailer Trucks
 - Class 12 Six-Axle Multi-Trailer Trucks
 - Class 13 Seven or More Axle Multi Trailer Trucks
