This Addendum Number Two supersedes all previous instructions pertaining to the items listed:

## **BID DUE DATE EXTENSION:**

In response to requests received from potential bidders, the Bid Due Date has been updated & extended as follows:

The Governing Body of the City of Cheyenne, Wyoming ("the Governing Body") will receive sealed bid proposals at the Office of the City Purchasing Agent, located in Room 309 of the Municipal Building at 2101 O'Neil Avenue, Cheyenne, WY 82001, until 2:00 p.m. local time on the <u>10<sup>th</sup> day of January, 2023</u> *3rd day of January, 2023* for the "17th Street Lighting Improvements Phase II" project.

## **QUESTIONS & RESPONSES:**

- Q1: For the purposes of the 5% or 10% Incentive, will project completion be based on Substantial Completion or Final Completion.
- A1: Basis for project acceptance in accordance with the 5% or 10% Incentive is Final Completion, not Substantial Completion. This is not inclusive of completion of the ABI for the Audio System.
- Q2: What will be the basis for award, Base Bid, or Base Bid + ABI?

- A2: Basis for award will be based on Base Bid, only.
- Q3: Is parking available to the Contractor in the adjacent parking garage?
- A3: The City will work with the awarded Contractor to obtain parking permits for the parking garage.
- Q4: Will temporary street lighting be required, while construction is underway and existing poles are removed?
- A4: No, temporary street lighting will not be required.
- Q5: What is the City's intent for the existing poles that are removed?
- A5: The City wishes to retain the removed existing lights. The City will work with the awarded Contractor to determine where the lights will be stored upon removal.
- Q6: Is the Contractor able to shut down both directions of travel on 17<sup>th</sup> Street?
- A6: No, 17<sup>th</sup> Street must maintain two-way traffic at all times. Parking lanes/spaces may be closed as needed to accommodate project completion.
- Q7: Do you know where I can find the details for the stamped concrete? The drawings reference "special spec. 03490". Does the City provide the stamp or will we need to buy that?
- A7: The information can be found in the City Standards. The City will provide the concrete stamps upon request.
- Q8: Separately, we're seeing that the electricians may struggle to get their pricing ready by the current deadline, especially right after a holiday week. You might consider moving the due date back a week.
- A8: Bid due date has been revised.
