The regular meeting of the Cheyenne Laramie County Economic Development Joint Powers Board assembled with a quorum at 7:31 a.m., in person and via Zoom, with Mike Williams, president presiding. Roll call was conducted.

Action Items

The Laramie County Economic Development Joint Powers Board meeting agenda for June 28, 2022, was presented for adoption. Brittany Ashby asked for an addition to the agenda in new business to discuss the number of signatories required on checks.

A Matt Pope/Sharon Fain motion was made and seconded to adopt the June 28, 2022; meeting agenda as presented with the addition of signatories in New Business. The motion passed unanimously.

The Laramie County Economic Development Joint Powers Board June 28, 2022, consent agenda was presented for adoption.

A Dr. JJ Chen/Trey Rinne motion was made and seconded to adopt the June 28, 2022, consent agenda; May 31, 2022, financials; and the June 2022 vouchers totaling \$20,965.40. The motion passed unanimously.

New Business

FY2023 Preliminary Budget Hearing

The Board discussed the budget especially the amount of funding from the County to be increased. Commissioner Malm explained how the County was planning to clean up the revolving loan account that it had been paying the Joint Powers Board by paying out a large contribution in addition to the usual \$20,000 yearly to equal the JPB requested amount of \$200,000. Malm stated that this would be decided and finalized at the next commissioner meeting. Mike Williams opened the preliminary budget for additional discussion. Since the county has yet to approve the Joint Powers Board request for increase of funding, he suggested a preliminarily vote and open for discussion. An increase of miscellaneous grants from \$50,000 to \$100,000 was requested.

A Kim Withers/Dr. JJ Chen motion was made to approve the preliminary with the assumption the County will approve the \$200,000 and the change in miscellaneous grants from \$50,000 to \$100,000. Motion carried.

Board Orientation

CPA Review Agreement

The SOW from Lenhart & Mason was not received in time for this meeting. Mike Williams tabled the approval of this agenda item until August.

Signatories

Brittany inquired about the history of two signatories per checks and opened for discussion on having just one signatory under a certain amount of money.

Kim Withers suggested the Board have just one signature since the control and audit risk is taken care of through communications in the consent agenda. Requiring two signatures is an unnecessary step. This requirement is not in the by-laws and only a procedural change. Since there are many levels of control, she is a proponent of having only signature.

A Matt Pope/Dr. JJ Chen motion was made to allow one signature on all checks. Motion carried.

Old Business

Cheyenne DDA Request for Funding 2022/2023

At the May 24, 2022, Joint Powers Board meeting, Haylee Chenchar, of the Downtown Development Authority, presented the funding request for 2022/2023 in the amount of \$20,000 to continue to fund the Capital Improvement Grant that drives the economic development of the downtown area. A report and review of the 2021/2022-year projects and how the JPB funding has helped the community was provided to the Board. A Board vote is needed. No further discussion.
