Action Items

The Laramie County Economic Development Joint Powers Board meeting agenda for April 25, 2023, was presented for adoption.

The Laramie County Economic Development Joint Powers Board April 25, 2023, consent agenda was presented for adoption.

A Rinne/Morris motion was made and seconded to adopt the April 25, 2023, consent agenda; March 28, 2023, meeting minutes; March 31, 2023, financials; and the April 2023 vouchers totaling \$2,189.20. The motion passed unanimously.

Economic Development Topics

Wyoming Legislators Sen. Tara Nethercott and Rep. Landon Brown gave a brief introduction and bio of themselves and then addressed the board with a 2023 Legislative Session update from their perspective. They also discussed what economic development impacts the session decisions may have on Laramie County.

Main tips from Legislators on how the Joint Powers Board can support economic development through state policy would be local distribution – be mindful of how your local legislators are voting on these from an economic development standpoint. This local distribution is in grave danger according to Sen. Nethercott. Be sure to communicate to your Laramie County legislators and that they are informed of the economic development issues.

Rep. Brown suggested making the JPB's positions well known to the legislators with open conversations as this is valuable from the chairman's perspective. Secondly, be available to testify to let people know that it's not just the city and counties that are running the eco-development agenda. Chey-Laramie County JPB can influence the legislation since they are local. Be available to testify.

Nick Colsch reported on the 2022-23 JPB Grant Accomplishments. There was a funding request for 2023/24 in the amount of \$73,000 billed quarterly at \$18,250. The Board will consider and vote at the May 2023 meeting.
