City of Cheyenne

Dr. Rinne reported on the council meeting on 9/26/2022. Highlights:

- 2003 the city adopted statutes on traffic laws, there's a change in state statues. City's would be updated. Since these weren't updated, the City held an emergency vote to update those ordinances.
- Multiple zone changes reported: apartments across from Menards on Del Range, tire store will be at that location
- Harmony Valley 69 acres with residential units
- Trying to get an agreement to develop Reed Avenue Corridor
- Rendering plant coming to Cheyenne will bring 2,000 jobs but they want 37% of available water
- Sales tax revenues have been up 6-13% from previous year
- Work session on Friday Oct 1
- Early voting started

- County continues to make progress on 6th penny projects
- Sending out RPF for sewer connector to open eco development in Archer
- Commercial leasing is at an all-time high in the area even though market for buying is down
 - o Transportation, Missile project, regional distribution centers

Betsey gave the LEADS stats and report for the month. Highlights:

- 9 new prospects since last month
- Staff roles at the LEADS office will be changing. Rochelle will take on an attraction role & marketing role; Jack community relations/member relations; Dawn is taking on Operations manager tasks.

DDA

Haylee Chenchar gave an update and report on DDA projects. Highlights:

- Rental assistance program -- help for business tenants cover up to 3 months' rent under emergency situations to keep business doors open was drafted approved.
 - o one-time only application process for the business.
- Mural program a call for artists out has been advertised for public art installations Downtown.
- App project is going well
- Store-front Program is in full swing, and many applications have been received for this grant.

CRAFT/Visit Cheyenne

Wendy Volk gave a CRAFT report. Highlights:

- 70k travelers since opening in Nov 2018
- Parking lot is full as many people are using the airport
- MOU with City & County to extending the parking lot is in process
- Final leg of construction service on runway is underway. SkyWest service going to be suspended in Spring of 2023
