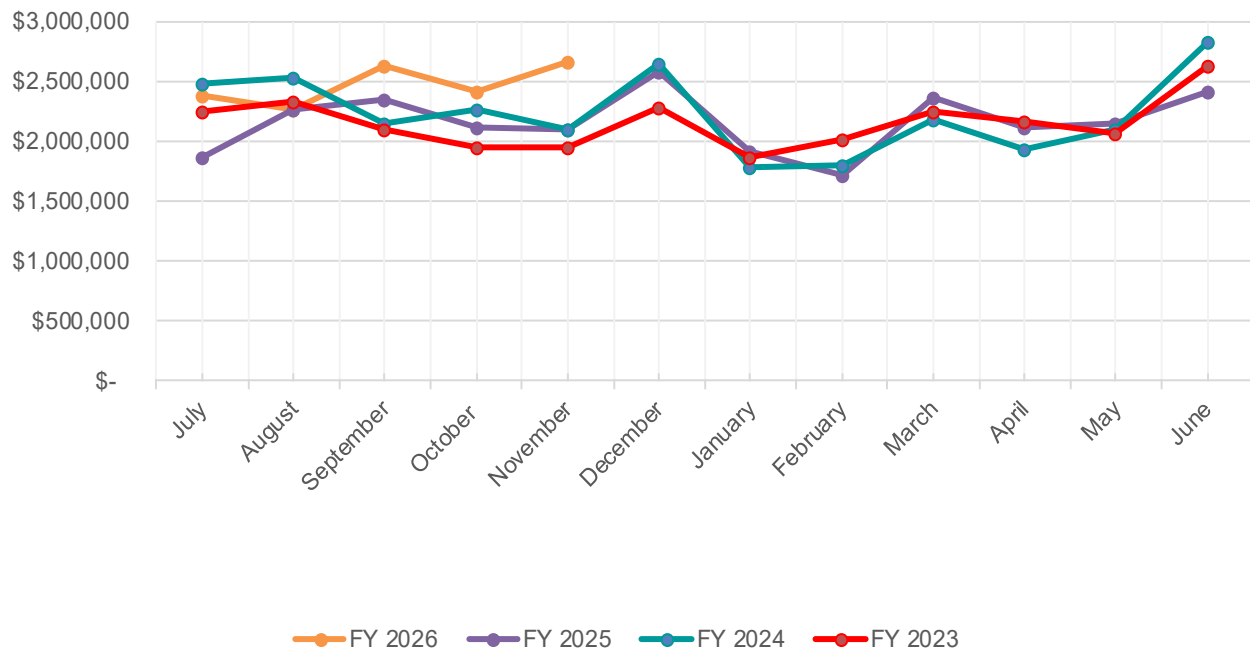

# SALES TAX COMPARISON OVERVIEW

## November 2024 versus November 2025 Analysis

The City's state sales tax collections payment for November 2025 was \$2,673,137 or \$571,868 more in revenue than the same time last year. On page 5, you will see a table that shows the variations by category of more than \$15,000 in sales taxes collected in Laramie County, comparing November 2024 to November 2025.

The most significant sales tax differences year-over-year that are greater or less than \$100,000 are as follows:

- 📈 **Electronic Shopping and Mail-order Houses.** Sales tax for this industry increased for the first time in several months. Compared to November 2024, this industry significantly increased by **\$641,734** in November 2025. This industry group comprises establishments primarily engaged in retailing all types of merchandise using non-store means, such as catalogs, toll free telephone numbers, or electronic media, such as interactive television or computer. Included in this industry are establishments primarily engaged in retailing from catalog showrooms of mail-order houses.
- 📈 **Electronics and Appliance Stores.** This industry group comprises establishments primarily engaged in retailing the following new products: household-type appliances, cameras, computers, and other electronic goods. These establishments typically cater to a business clientele and do not generally operate a retail-like or storefront facility. Sales tax for this industry increased by **\$577,554** in November 2025.
- 📈 **Consumer Goods Rental.** Sales tax for this industry increased by **\$513,588** in November 2025 compared to November 2024. This industry group comprises establishments primarily engaged in renting personal and household type goods. Establishments classified in this industry group generally provide short term rental although in some instances the goods may be leased for longer periods of time. These establishments often operate from a retail like or storefront facility.
- 📈 **Electronic Equipment Repair and Maintenance.** This industry group comprises establishments primarily involves diagnostics, preventative maintenance, emergency repairs, parts replacement, and technical support for complex electronic and precision instruments across various industries. The services require highly trained technicians, often with original equipment manufacturer (OEM) certifications, who can effectively diagnose, maintain, and restore specialized equipment to optimal operational conditions. In comparison to November 2024, sales tax for this industry increased by **\$314,072** in November 2025.
- 📈 **Machinery and Equipment Rental and Leasing.** Compared to the same time last year, sales tax for this industry increased by **\$207,854**. This industry group comprises establishments primarily engaged in renting or leasing commercial-type and industrial-type machinery and equipment. Establishments included in this industry group are generally involved in providing capital or investment-type equipment that clients use in their business operations. These establishments typically cater to a business clientele and do not generally operate a retail-like or storefront facility.
- 📈 **Power Generation and Supply.** This industry group comprises establishments primarily engaged in generating, transmitting, and/or distributing electric power. Establishments in this industry group may perform one or more of the following activities: (1) operate generation facilities that produce electric energy; (2) operate transmission systems that convey the electricity from the generation facility to the distribution system; and (3) operate distribution systems that convey electric power received from the generation facility or the transmission system to the final consumer. Sales tax for this industry increased by **\$131,214** compared to November 2024.

- ↑ **Automotive Repair and Maintenance.** Compared to November 2024, sales tax for this industry increased by **\$107,114** in November 2025. This industry group comprises establishments involved in providing repair and maintenance services for automotive vehicles such as passenger cars trucks and vans and all trailers Establishments in this industry group employ mechanics with specialized technical skills to diagnose and repair the mechanical and electrical systems for automotive vehicles repair automotive interiors and paint or repair automotive exteriors.
- ↑ **Electric Goods Merchant Wholesalers.** Sales tax for this industry increased by **\$100,214** in compared to the same time last year. This industry group comprises establishments primarily engaged in the merchant wholesale distribution of electrical apparatus and equipment, wiring supplies, and related equipment; household appliances, electric housewares, and consumer electronics; and other electronic parts and equipment.
