

SALES TAX COMPARISON OVERVIEW

October 2024 versus October 2025 Analysis

The City's state sales tax collections payment for October 2025 was \$2,408,449 or \$300,090 more in revenue than the same time last year. On page 5, you will see a table that shows the variations by category of more than \$15,000 in sales taxes collected in Laramie County, comparing October 2024 to October 2025.

The most significant sales tax differences year-over-year that are greater or less than \$100,000 are as follows:

- ↑ **Executive, Legislative and General Government.** Sales tax for this industry increased for the second consecutive month by **\$484,495** compared to October 2024. This industry group is primarily used by governments including Laramie County to report sales and use tax collections on all vehicle purchases, except motorcycles, obtained from a Wyoming dealer.
- ↑ **Support Activities for Mining.** Sales tax for this industry increased by **\$175,201** in October 2025 compared to October 2024. This industry comprises establishments primarily engaged in providing support services, on a contract or fee basis, required for the mining and quarrying of minerals and for the extraction of oil and gas. Drilling, taking core samples, and making geological observations at prospective sites (except geophysical surveying and mapping) for minerals, on a contract or fee basis, is included in this industry.
- ↑ **Machinery and Equipment Rental and Leasing.** This industry group comprises establishments primarily engaged in renting or leasing commercial-type and industrial-type machinery and equipment. Establishments included in this industry group are generally involved in providing capital or investment-type equipment that clients use in their business operations. These establishments typically cater to a business clientele and do not generally operate a retail-like or storefront facility. In comparison to October 2024, sales tax for this industry increased by **\$156,852** in October 2025. .
- ↑ **Power Generation and Supply.** This industry group comprises establishments primarily engaged in generating, transmitting, and/or distributing electric power. Establishments in this industry group may perform one or more of the following activities: (1) operate generation facilities that produce electric energy; (2) operate transmission systems that convey the electricity from the generation facility to the distribution system; and (3) operate distribution systems that convey electric power received from the generation facility or the transmission system to the final consumer. Sales tax for this industry increased by **\$121,753** in October 2025.
- ↑ **Other Miscellaneous Store Retailers.** This industry comprises establishments primarily engaged in retailing new goods in general merchandise stores (except department stores, warehouse clubs, superstores, and supercenters). These establishments retail a general line of new merchandise, such as apparel, automotive parts, dry goods, hardware, housewares or home furnishings, and other lines in limited amounts, with none of the lines predominating. Sales tax for this industry increased by **\$116,496** in compared to the same time last year.
- ↓ **Electronic Shopping and Mail-order Houses.** Sales tax for this industry has continued to decrease for the third consecutive month. Compared to October 2024 this industry decreased by **\$387,122** in October 2025. This industry group comprises establishments primarily engaged in retailing all types of merchandise using non-store means, such as catalogs, toll free telephone numbers, or electronic media, such as interactive television or computer. Included in this industry are establishments primarily engaged in retailing from catalog showrooms of mail-order houses.

October 2024 versus October 2025 Analysis (Continued)

- ⬇ **Traveler Accommodations.** This industry group comprises establishments primarily engaged in providing short-term lodging in facilities, such as hotels, motels, casino hotels, and bed-and-breakfast inns. In addition to lodging, these establishments may provide a range of other services to their guests. Sales tax for this industry decreased by **\$116,493** compared to the same time last year.
