ORDINANCE -2nd READING - Creating Chapter 2.96, Ethical Obligations of Public Officials, Public Members and City Employees, of Title 2, Administration and Personnel, of the Municipal Code of the City of Cheyenne, Wyoming, specifying the ethical duties and obligations of Public Officials, Public Members and Employees of the City of Cheyenne. Mr. Laybourn moved to approve on 2nd reading, seconded by Dr. Rinne. Dr. Rinne moved to postpone until the July 10, 2023, meeting of the governing body, seconded by Mr. Laybourn. Motion to postpone carried by unanimous voice vote.

19. ORDINANCE -2nd READING – Amending the Official Zoning Map of the City of Cheyenne changing the zoning classification from LI Light Industrial and MR Medium-Density Residential to MR Medium-Density Residential for land located on Lots 14 and 15, Christensen Park. (SPONSOR – MR. COOK)

20. ORDINANCE -2nd READING - Amending Section 2.4.2 Annexations of the Unified Development Code, and creating Section 2.2.8, Assigned Zoning, clarifying City zone assignment processes in concert with annexations and when removing City zone districts. (SPONSOR - MR. COOK)

Dr. Rinne moved to approve on 2nd reading, seconded by Dr. Aldrich. Motion carried with Dr. Aldrich and Dr. Rinne voting "YES" and Mr. Laybourn voting "NO".

21. ORDINANCE –2nd READING – Amending Section 2.2.1.c.5 and 2.2.2.c.6 of the Unified Development Code (UDC), amending protest petitions for zoning map amendments and planned developments. (SPONSOR – MR. COOK)

Dr. Rinne moved to approve on 2nd reading. Motion died due the lack of a second.

Chairman Segrave and committee members Aldrich and Rinne commented on the item. Public comment was made by Rebecca Murchie, Jason Stevens, and Elizabeth Stapel.

Lucas Buckley, applicant, provided information related to the requested postponement. Committee member Laybourn commented on the item.
