ORDINANCE -3rd READING - Amending Section 15.08.031, Building Permit Fees-Exceptions for Incentivization Program, of Chapter 15.08, International Building Code Adopted, of Title 15, Buildings and Construction, of the Code of the City of Cheyenne, Wyoming, to create incentives for attainable housing and historic preservation.

Dr. Rinne moved to approve on 3rd and final reading, seconded by Mr. Segrave. Motion carried with Dr. Rinne and Mr. Segrave voting "YES" and Mr. Laybourn voting "NO".

13. ORDINANCE -2nd READING - Amending the Official Zoning Map of the City of Cheyenne changing the zoning classification from MUB Mixed-Use Business Emphasis to P Public District for land located at Lot 1, Block 1, Back 40 Subdivision, Third Filing. (SPONSOR - MR. COOK)

14. ORDINANCE -2nd READING - Amending the Official Zoning Map of the City of Cheyenne changing the zoning classification from CB Community Business to MUB Mixed-Use Business for land located on Lots 3, 4, 5, 6, 7, and 8, Block 1, Hitching Post Plaza, 3rd Filing. (SPONSOR - MR. COOK)
