7. ORDINANCE -3<sup>rd</sup> READING - Amending Section 10.16.150, Parking Violation Hearings and Appeal Procedures, of the Municipal Code of the City of Cheyenne, Wyoming, modifying the procedures governing the Administrative Review of Parking Citations, making conforming amendments and repealing an obsolete provision.

Mr. Segrave moved to approve on 3<sup>rd</sup> and final reading, seconded by Mr. Laybourn. Motion carried by unanimous voice vote.

Captain David Janes, Police Department, provided a staff report.

8. ORDINANCE -3<sup>rd</sup> READING - Creating Section 10.60.015, Paid On-Street Parking Districts; Establishment, Administration, of the Municipal Code of the City of Cheyenne, Wyoming, establishing the Paid On-Street Parking Districts Program and making conforming amendments as specified.
