7. ORDINANCE –3rd READING – Creating Chapter 8.72, Private Displays on Public Property, to prohibit the unauthorized use of public property for specified private displays.

ACTION:

8. ORDINANCE –3rd READING – Amending the Official Zoning Map of the City of Cheyenne, changing the zoning classification for certain land located north of Prairie Avenue, east of Powderhouse Road, west of Rue Terre, and south of Storey Boulevard from AG – Agricultural to NR-3 – Neighborhood Residential High Density.
