

RESOLUTION NO. _____

ENTITLED: “A RESOLUTION DESIGNATING THE ALLOCATION OF WYOLOTTO REVENUES STATUORILY DEDICATED TO THE CITY OF CHEYENNE BE DISTRIBUTED TO COMMUNITY RECREATION AND EVENTS FOR THE PURPOSE OF CONSTRUCTION, REMEDIATION, AND COMPLETION OF QUALITY OF LIFE PROJECTS IN THE CITY OF CHEYENNE FOR A FIVE (5) YEAR PERIOD.”

WHEREAS, the City of Cheyenne (“City”) recognizes the need for improvement for Quality of Life amenities throughout the entire municipality; and

WHEREAS, pursuant to Wyoming Statute § 9-17-111(b) “Disposition of lottery proceeds”, these monies shall be paid by the treasurer to the treasurers of the counties, cities and towns for payment into their respective general funds; and

WHEREAS, the percentage of the balance that will be distributed to each city will be determined by computing the percentage that sales of lottery tickets collected by retailers that city to total sales of lottery tickets collected by retailers in all counties including their cities and towns. This percentage of the monies shall be distributed to the City of Cheyenne relative to its population within Laramie County; and

WHEREAS, the monies allocated from this resolution received from the WyoLotto revenue to the City shall be used for the construction, remediation, and completion of, but not limited to, projects deemed a high priority by the director of Community Recreation and Events, or his or her designee, to be presented annually by resolution to the governing body for consideration and appropriation; and

WHEREAS, the monies allocated from this resolution received from the WyoLotto revenue to the City may be used for potential grant matches for the construction, remediation, and completion of, but not limited to, projects deemed a high priority by the director of Community Recreation and Events, or his or her designee, to be presented to the governing body for consideration following standard operating procedures for pursuing grant funding laid out by the City; and

WHEREAS, the monies allocated from this resolution received from the WyoLotto revenue to the City may not be used to compensate for lost wages, payroll, or overtime costs; and

WHEREAS, the monies allocated from this resolution received from the WyoLotto revenue to the City may not be used to create new or update strategic plans, but are intended to display tangible results to the community at large that quality of life projects are being completed; and

WHEREAS, this resolution shall become effective beginning July 1, 2022 and shall be deemed in effect for the period of five (5) years where the resolution will be reconsidered for extension by the governing body.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF CHEYENNE, WYOMING, that the City of Cheyenne hereby designates the allocation of WyoLotto revenues to the City of Cheyenne be distributed to Community Recreation and Events for the purpose of construction, remediation, and completion of quality of life projects in the City of Cheyenne for a period of five (5) years.
