8. ORDINANCE -2nd READING - Amending Chapter 10.44, Weight Limits, of Title 10, Vehicles and Traffic, of the Municipal Code of the City of Cheyenne, Wyoming. (POSTPONED FROM OCTOBER 26, 2020)

Mr. Shanor moved to approve on 2nd reading, seconded by Mr. Roybal. Mr. Shanor moved to amend by substitute titled "November 3, 2020 Amendment to October 26, 2020 Amendment", seconded by Mr. Roybal. Motion to amend by substitute carried by unanimous voice vote. Motion as amended carried by unanimous voice vote.

DISCUSSION: Chief Brian Kozak, Police Department, provided a staff report and advised a draft amendment has been provided and mutually agreed upon. Tom Cobb, City Engineer, commends staff efforts but requested more time to review the ordinance with other parties involved. Sheila Foertsch, Wyoming Trucking Association, advised the community is still learning about this ordinance and agreed more time would be beneficial to all parties involved. Joe Wiesen, Knife River, voiced opposition and requested more time.

9. ORDINANCE -3rd READING - Amending Section 8.56.070, Loudspeakers, Sound Cars, and Sound Trucks, of Chapter 8.56, Noise Control, of Title 8, Health and Safety, of the Municipal Code of the City of Cheyenne, Wyoming.

Mr. Roybal moved to approve on 3rd and final reading, seconded by Mr. Cook. Motion carried by unanimous voice vote.

10. ORDINANCE -3rd READING - Amending the Official Zoning Map of the City of Cheyenne changing the zoning classification from HR (High-Density Residential) to CB (Community Business) for property generally located east of Interstate 25 and north of Central Avenue adjacent to Hynds Boulevard.

Mr. Cook moved to approve on 3rd and final reading, seconded by Mr. Roybal. Motion carried by unanimous voice vote.

11. ORDINANCE -3rd READING - Amending the Official Zoning Map of the City of Cheyenne changing the zoning classification of Lot 1, Block 2 and Lot 1, Block 3, Back 40 Subdivision Second Filing from MUB (Mixed-Use Business Emphasis) to CB (Community Business) for property generally located north of West Lincolnway at Grant Avenue.

Mr. Roybal moved to approve on 3rd and final reading, seconded by Mr. Cook. Motion carried by unanimous voice vote.

12. ORDINANCE -3rd READING - Vacating the entirety of the Stinson Avenue right-of-way lying between Blocks 404 and 410, Original City, Cheyenne, Laramie County, Wyoming and south of West Lincolnway Highway.
