ENTITLED: "AN ORDINANCE REPEALING ORDINANCE NO. 3465, AND REESTABLISHING AND REDEFINING WARD BOUNDARIES WITHIN THE CITY OF CHEYENNE

BE IT HEREBY ORDAINED BY THE GOVERNING BODY OF THE CITY OF CHEYENNE WYOMING:

Section 1. Ordinance No. 3465 is repealed in its entirety.

Section 2. There are created and established within the City of Cheyenne three wards defined as follows:

WARD ONE

All of those areas annexed to the City of Cheyenne within an area described as follows:

Commencing at a point of beginning at the intersection of the centerline of Dell Range Boulevard and the centerline of Converse Avenue; **THENCE** Southerly along the centerline of Converse Avenue to the intersection of the centerlines of East Lincolnway and Converse Avenue; **THENCE** Westerly along the centerline of East Lincolnway to the intersection of the centerlines of Logan Avenue and East Lincolnway; **THENCE** Southeasterly along the centerline of Logan Avenue to the intersection of the centerline of Nationway; **THENCE** Southeasterly along the centerline of Nationway to the intersection of the East section line of Section 32, T14N, R66W; **THENCE** Southerly along the East section line of Section 32, T14N, R66W to the Southeast section corner of Section 32, T14N, R66W; **THENCE** Westerly to the East boundary of Original City; **THENCE** Southeasterly along the East boundary of Original City to the Southeast corner of Original City; **THENCE** Southwesterly along the South boundary of Original City to the intersection of the centerline of Morrie Avenue; **THENCE** Southeasterly along Morrie Avenue to the intersection of the centerline of East Fox Farm Road; **THENCE** Westerly on East Fox Farm Road to the intersection of the centerline of South Greeley Highway; **THENCE** Southerly along the centerline of South Greeley Highway to the intersection of the South section line of Section 33, T13N, R66W; **THENCE** Westerly along the South section line for the next seven (7) sections to the Southwest corner of Section 32, T13N, R67W; **THENCE** Northerly along the West section line for the next nine and a half (9½) sections to the intersection of the centerline of Polo Ranch Road; **THENCE** Southeasterly along the centerline of Polo Ranch Road to the intersection of Round Top Road; **THENCE** Northerly along the centerline of Round Top Road to the Northwest corner of Section 15, T14N, R67W also known as the Northwest corner of Francis E. Warren Air Force Base; **THENCE** Around the North and East Boundaries of Francis E. Warren Air Force Base to the intersection of the centerline of Central Avenue; **THENCE** Southeasterly along the centerline of Central Avenue to the intersection of the centerline of Yellowstone Road; **THENCE** Northerly along the centerline of Yellowstone Road to the intersection of the centerline of Dell Range Boulevard; **THENCE** Easterly along the centerline of Dell Range Boulevard to the intersection of the centerline of Dry Creek; **THENCE** Easterly along the centerline of Dry Creek to the intersection of the centerline of Dell Range Boulevard; **THENCE** Easterly along the

centerline of Dell Range Boulevard to the point of beginning.

WARD TWO

All of those areas annexed to the City of Cheyenne within an area described as follows:

Commencing at a point of beginning at the intersection of the centerline of Dell Range Boulevard and the centerline of Converse Avenue; **THENCE** Easterly along the centerline of Dell Range Boulevard to the intersection of the centerline of Cleveland Avenue; **THENCE** Southerly along the centerline of Cleveland Avenue to the intersection of the centerline of Rio Verde Street; **THENCE** Easterly along the centerline of Rio Verde Street to the intersection of the centerline of Pierce Avenue (at this point Rio Verde Street changes to Green River Street); **THENCE** Easterly along the centerline of Green River Street to the intersection of the centerline of Van Buren Avenue; **THENCE** Southerly along the centerline of Van Buren Avenue to the intersection of the centerline of Eastview Street; **THENCE** Easterly along the centerline of Eastview Street to the intersection of the centerline of Hayes Avenue; **THENCE** Northerly along the centerline of Hayes Avenue to the intersection of the centerline of Greenmeadow Drive; **THENCE** Westerly along the centerline of Greenmeadow Drive to the intersection of the east boundary line of Valley Vista Subdivision; **THENCE** Northerly along the east and north boundary of Valley Vista Subdivision to the intersection of the centerline of Dell Range Boulevard; **THENCE** Easterly along the centerline of Dell Range Boulevard to the intersection of the centerline of U.S. Highway 30; **THENCE** Easterly along centerline of U.S. Highway 30 to the Southeast corner of Section 21, T14N, R65W; **THENCE** Northerly along the East section line for the next five (5) sections to the Northeast corner of Section 33, T15N, R65W; **THENCE** Westerly along the North section line for the next fourteen (14) sections to the Northwest corner of Section 32, T15N, R67W; **THENCE** Southerly along the West section line for the three and a half (3½) sections to the intersection of the centerline of Polo Ranch Road; **THENCE** Southeasterly along the centerline of Polo Ranch Road to the intersection of Round Top Road; **THENCE** Northerly along the centerline of Round Top Road to the Northwest corner of Section 15, T14N, R67W also known as the Northwest corner of Francis E. Warren Air Force Base; **THENCE** Around the North and East Boundaries of Francis E. Warren Air Force Base to the intersection of the centerline of Central Avenue; **THENCE** Southeasterly along the centerline of Central Avenue to the intersection of the centerline of Yellowstone Road; **THENCE** Northerly along the centerline of Yellowstone Road to the intersection of the centerline of Dell Range Boulevard; **THENCE** Easterly along the centerline of Dell Range Boulevard to the intersection of the centerline of Dry Creek; **THENCE** Easterly along the centerline of Dry Creek to the intersection of the centerline of Dell Range Boulevard; **THENCE** Easterly along the centerline of Dell Range Boulevard to the point of beginning.

WARD THREE

All of those areas annexed to the City of Cheyenne within an area described as follows:

Commencing at a point of beginning at the intersection of the centerline of Dell Range Boulevard and the centerline of Converse Avenue; **THENCE** Southerly along the centerline of Converse Avenue to the intersection of the centerlines of East Lincolnway and Converse Avenue; **THENCE** Westerly along the centerline of East Lincolnway to the intersection of the centerlines of Logan Avenue and East Lincolnway; **THENCE** Southeasterly along the centerline of Logan Avenue to the intersection of the centerline of Nationway; **THENCE** Southeasterly along the centerline of Nationway to the intersection of the East section line of Section 32, T14N, R66W; **THENCE** Southerly along the East section line of Section 32, T14N, R66W to the Southeast section corner of Section 32, T14N, R66W; **THENCE** Westerly to the East boundary of Original City of Cheyenne; **THENCE** Southeasterly along the East boundary of Original City of Cheyenne to the Southeast corner of Original City; **THENCE** Southwesterly along the South boundary of Original City to the intersection of the centerline of Morrie Avenue; **THENCE** Southeasterly along Morrie Avenue to the intersection of the centerline of East Fox Farm Road; **THENCE** Westerly on East Fox Farm Road to the intersection of the centerline of South Greeley Highway; **THENCE** Southerly along the centerline of South Greeley Highway to the intersection of the South section line of Section 33, T13N, R66W; **THENCE** Easterly along section line for the next seven (7) sections to the Southeast corner of Section 33, T13N, R65W; **THENCE** Northerly along the East section line for the next eight (8) sections to the intersection of the centerline of U.S. Highway 30; **THENCE** Westerly along centerline of U.S. Highway 30 to the intersection of the centerline of Dell Range Blvd; **THENCE** Westerly along the centerline of Dell Range Boulevard to the intersection of the east boundary line of Valley Vista Subdivision; **THENCE** Southerly along the east and north boundary of Valley Vista Subdivision to the intersection of the centerline of Greenmeadow Drive; **THENCE** Westerly along the centerline of Greenmeadow Drive to the intersection of the centerline of Hayes Avenue; **THENCE** Southerly along the centerline of Hayes Avenue to the intersection of the centerline of Eastview Street; **THENCE** Westerly along the centerline of Eastview Street to the intersection of the centerline of Van Buren Avenue; **THENCE** Northerly along the centerline of Van Buren Avenue to the intersection of the centerline of Green River Street; **THENCE** westerly along the centerline of Green River Street to the intersection of the centerline of Pierce Avenue (at this point Green River Street changes to Rio Verde Street); **THENCE** continuing Westerly along the centerline of Rio Verde Street to the intersection of the centerline of Cleveland Avenue; **THENCE** Northerly along the centerline of Cleveland Avenue to the intersection of the centerline of Dell Range Boulevard; **THENCE** Westerly along the centerline of Dell Range Boulevard to the point of beginning.

Section 3. This ordinance establishes ward boundaries governing all municipal elections, including elections for governing body officers beginning with the 2022 primary and general elections for those taking office on the first Monday in January 2023.

Section 4. This ordinance shall be in full force and effect upon passage and publication.
