### **AGENDA ITEMS**

13. ORDINANCE –3<sup>rd</sup> READING – Amending various sections of Chapter 15.08, 15.09, 15.10, 15.12, 15.16, 15.22, 15.24 and 15.26 of Title 15, Buildings and Construction, of the Municipal Code of the City of Cheyenne, Wyoming, updating specified building code requirements and fees adopted by the city. (SPONSOR – MR. ROYBAL)

Mr. Cook moved to approve on 3<sup>rd</sup> and final reading, seconded by Mr. White. Motion carried with Mr. Segrave voting “NO”.

Antony Pomerleau, Interim Chief Building Official, provided a staff report. Committee member Laybourn commented on the item.

14. ORDINANCE – 3<sup>rd</sup> READING – Amending Section 2.84.050, International Fire Code Board of Appeals, of Chapter 2.84, Miscellaneous Boards and Commissions, of Title 2, Administration and Personnel, of the Municipal Code of the City of Cheyenne, Wyoming, pertaining to the International Fire Code Board of Appeals. (SPONSOR – MR. ROYBAL)

Mr. Cook moved to approve on 3<sup>rd</sup> and final reading, seconded by Mr. Roybal. Motion carried by unanimous voice vote.

Division Chief Byron Matthews, Fire & Rescue Department, provided a staff report. Committee members Aldrich, Esquibel, and Roybal commented on the item.

15. ORDINANCE –3<sup>rd</sup> READING – Amending various sections within Chapter 8.12, International Fire Code Adopted, of Title 8, Health and Safety, of the Municipal Code of the City of Cheyenne, Wyoming, updating the edition of the International Fire Code adopted by the City and further amending as specified. (SPONSOR – MR. ROYBAL)

Mr. Roybal moved to approve on 3<sup>rd</sup> and final reading, seconded by Mr. Cook. Mr. Segrave moved to amend by adding back into the document under section 8.12.030 letter “F” and renumber the document as necessary, seconded by Dr. Rinne. Motion failed with Dr. Aldrich, Mr. Cook, Mr. Esquibel, Mr. Laybourn, and Mr. Roybal voting “NO”. Main motion carried with Dr. Rinne and Mr. Segrave voting “NO”.

Division Chief Byron Matthews, Fire & Rescue Department, provided a staff report and Stefanie Boster, City Attorney, provided additional information. Committee members Aldrich, Roybal, and Segrave commented on the item.
